I. Call to Order by Cora at 9:32 a.m.
II. Minutes of the Previous Meeting approved: Kelly motioned, Janet seconded.
III. Administration- Excited about the upcoming carnival. Janet will be picking up the banner/ photo op. CME is adding a $4^{\text {th }}$ grade class starting Monday, October 15. All children will be affected. Working on a grant application form (preliminary) for teachers to use in reference to the unused PTO funds. Thank you for the new tablecloths in the Teachers' Lounge.

Classroom teachers will be reinforcing this concept as well. Storybook pumpkins due on the $15^{\text {th }}$ with the stroll on $31^{\text {st }}$. Updated club information on website shortly and main calendar. All coding information is in Schoology; Running club started this
morning. New program: 1 Book, 1 School will start in October. Every family will receive a copy of the same book and activities at school will correspond. Celebration in February for Literacy Night will focus on this book. Book to be announced soon.
V. Reports of Executive Officer
a. President- Fazia is our new Parliamentarian.
b. Vice President- Bullying show for entire school on $8^{\text {th }}$ presented by Alley Theater. Jennifer Torrez is the author visit for $2^{\text {nd }}-5^{\text {th }}$ grade on $16^{\text {th }}$.
c. Treasurer- Discussion on discrepancy in budget from last Spring until now. A series of very conservative estimates for spending, coupled with a large discrepancy on carryover means that there is a large amount left to spend. For this year, many of the previously cut budget items will need to be sent back through the Gifts Committee if they want to reinstate or increase their budget (ie. Landscaping). Only two line items will be discussed for change today: Gifts and Classroom Enhancement Fund. Discussion on increasing the teacher supply fund from $\$ 50$ to $\$ 160$. Because many teachers were not told the budget was cut, they have already spent the previously budgeted amount of $\$ 150$. Kelly motions to increase the Classroom Enhancement Fund to $\$ 6,000$. Jennifer seconds the motion. The motion passes. Jenni motions to move the remaining excess of $\$ 32,000$ to the Gifts Committee for dispersion. Sarah seconds. The motion passes. Teachers will be invited to submit a gift request if they have an idea for funding.
